

Child Custody Dispute Form

The Citizen Report Child Custody Dispute Form is designed to remove police officers from the process of documenting Child Custody Disputes. It is to be completed by the citizen and kept for your own records. Records may provide an incident number for you if requested. Hanford Police Department will not generate a case number for these incidents, unless specific elements exist below. If you have questions about your situation, you can request to speak with an officer.

Child Custody Disputes – For non-violent child visitation violations. > *Use Child Custody Dispute Form.*

Do not use this form if violence is involved; there is a possibility of danger to the child; kidnapping or abduction is suspected, or you want to file a Missing Juvenile Report.
